Q3 2022 Market Commentary⁴

Global markets continued to decline in the third quarter of 2022, with the S&P 500 and MSCI World indices returning -4.9% and -6.1% on the quarter, bringing year to date returns to -23.9% and -25.1%, respectively.⁵ Inflation remained at the top of headlines as the market looked to anticipate the Federal Reserve's stance ahead of key meetings in Q3, being influenced directionally with their policy decisions. Outside of the US, rising geopolitical tensions have deteriorated Europe's economic outlook as the Russia-Ukraine conflict continues to put pressures on supply. Together, these factors posed significant challenges for global markets, likely contributing to negative performance on the quarter.

After rallying in July and the first half of August on perceived peak inflation data, major market indices pivoted mid-month to finish broadly lower following hawkish comments from Jerome Powell that effectively quashed the popular narrative of a near-term Fed Pivot. The August 10th reading of July CPI at 8.5% (vs. the expected 8.7%)⁶ added credence to the peak inflation narrative which hinted at the possibility for the Fed to ease the aggressiveness of their monetary policy decisions through the end of the year. Despite this lower-than-expected CPI reading, Jerome Powell reiterated the need for sustained higher interest rates in an effort to avoid the resurgence of inflation seen in the 1980s after the Fed cut rates prematurely. Following these comments from the Fed, markets sold-off strongly into a multi-week losing streak before bouncing back ahead of the subsequent release of inflation data. The rebound was short lived as markets declined sharply after August CPI numbers came in 20bps higher than expected for both headline (8.3% vs. 8.1%) and Core (6.3% vs. 6.1%).⁷

Geopolitical events also weighed on major indices as tensions abroad continued to escalate. Russia leaned further into the conflict in Ukraine, holding referendums in occupied territories and announcing a 300,000 person "mobilization" from the general Russian population. Additionally, Russia completely shut off gas flows through the Nord Stream 1 pipeline at the beginning of September, adding to the concerns surrounding the ongoing European energy crisis. While import levels in Liquid

Natural Gas (“LNG”) to the region have increased, the supply constraints have seen energy prices rise exponentially (as much as +700% YTD in Germany)⁸, forcing policy makers to intervene on behalf of households.⁸

Despite two consecutive quarters of negative GDP growth⁹, the US economy has remained resilient throughout the third quarter on the back of a strong labor market and record high corporate profits. With more jobs added and initial jobless claims low and falling in recent weeks, tight labor markets likely continued to drive elevated wage growth with average hourly earnings having grown 5.2% year-over-year in August and sustained momentum in the US jobs market (315,00 payroll jobs added in August).¹⁰ Corporate profits in the US rose 6.2% to \$2.53 trillion.¹¹ However stickier inflation, elevated wage growth, and a higher cost of capital are all ingredients that may place downward pressure on profit margins.¹² While analysts continue to forecast record profit margins for the S&P 500 next year, the coming earnings season may result in some downward revisions in the coming months.¹²

Against this macroeconomic backdrop, challenges in the global market are becoming more apparent, suggesting that the recession narrative alluded to last quarter is still at play. Taking these factors into consideration, BXMIX is positioning to be underweight strategies with directional market exposure and overweight relative value and direct trading strategies across macro rates, credit, and commodities.

Review of Q3 2022 Fund Performance

The investment objective of the Blackstone Alternative Multi-Strategy Fund is to seek capital appreciation. The Fund aims to achieve its objective by allocating assets among a variety of investment sub-advisers, each with experience managing non-traditional or “alternative” investment strategies and by managing assets directly (via BAIA¹³). In Q3, the Fund’s Class I share class returned -1.5%¹ net of fees and expenses versus 0.5% for the HFRX Global Hedge Fund Index, -7.0% for the Barclays Global Aggregate Bond Index, and -6.1% for the MSCI World Index.¹³

Equity Strategies¹⁴

Equity strategies (-0.59%) generated losses on the quarter. Equity Long/Short sub-strategies saw mostly negative performance in Q3, taking on losses from long positions in a commodity chemicals company. Additional losses were generated from the Fund’s equity exposure to Media and Technology sectors, both of which declined with the broader market. Exposure to equities in healthcare and biotech was additive to overall Fund performance as both sectors rallied in July and the beginning of August.

Equity Market Neutral sub-strategies had mixed performance on the quarter with losses concentrated in the Fund’s exposure to equity positions in the payments sector, which likely suffered as the market continued to rotate out of growth. Gains in this portion of the book were attributed to a Quantitative sub-strategy that benefited from the continued market volatility in the third quarter.

Credit Strategies¹⁴

Credit strategies (0.47%) were the largest contributor performance for the quarter. A sub-strategy focused on Agency mortgage spreads over US treasuries (the “MBS Basis” spread) was the largest positive contributor to Credit performance, gaining as the Mortgage Basis spread widened throughout the quarter. A Fixed Income – Asset Backed sub-strategy was accretive to performance as well, benefiting from volatility in the debt market and interest rates in Q3. A Fixed Income – Sovereign debt focused strategy took on losses as rising yields in emerging market debt led to weak price performance on the quarter.

Distressed/Restructuring sub-strategies were accretive to Fund performance in the third quarter, generating gains from long bond exposure to a health care facilities & services company, which completed the financial restructuring of its balance sheet in

July, reducing the company's debt significantly. Exposure to bonds in a cruise operating company benefitted from the continued ease of Covid restrictions and an increase of cruise bookings.

Multi-Asset Strategies¹⁴

Multi-Asset strategies (-0.66%) were the largest detractor from Fund performance. The Fund's exposure to several short interest rate positions were additive to performance throughout the quarter, as interest volatility remained elevated in the third quarter. The Fund's exposure to reinsurance strategies proved to detract from Fund performance as a result of damages from Hurricane Ian towards the end of Q3. Additional losses emanated from the Fund's positions in Scandinavian fixed income relative value strategies, due to negative performance from the widening of covered bond spreads.

A sub-strategy focused on Carbon Credit Allowances ("CCAs") was the largest detractor to overall Fund performance for the quarter, likely suffering from the broader market drawdown.

Sub-Advisers and Strategies Added/Removed

At Blackstone, we believe that managing the optimal mix of strategies across the portfolio and adjusting it over time are key generating returns in different market environments. Over the course of the third quarter, there were no new sub-advisers added and no sub-advisers removed.

Additions and terminations are normal events in our investment process and result from our dynamic evaluation of the top-down assessment of the opportunity set for specific investment strategies as well as the bottom-up evaluation of a sub-adviser's ability to deliver alpha in a given environment.

Russian Invasion of Ukraine. On February 24, 2022, Russian troops began a full-scale invasion of Ukraine and, as of the date of this Material, the countries remain in active armed conflict. Around the same time, the United States, the United Kingdom, the European Union, and several other nations announced a broad array of new or expanded sanctions, export controls, and other measures against Russia, Russia-backed separatist regions in Ukraine, and certain banks, companies, government officials, and other individuals in Russia and Belarus. Selection of Sub-Advisers. Blackstone compensates the Sub-Advisers out of the management fee it receives from the Fund. This could create an incentive for Blackstone to select Sub-Advisers with lower fee rates.

Financial Interests in Sub-Advisers and Service Providers. Blackstone, the Sub-Advisers, and their affiliates have financial interests in asset managers and financial service providers. Allocating to an affiliate (or hiring such entity as a service provider) benefits Blackstone Inc. and the relevant Sub-Adviser and redemptions from an affiliate (or terminating such entity as a service provider) would be detrimental to Blackstone Inc. and the relevant Sub-Adviser. For example:

- *Blackstone Strategic Alliance Advisors L.L.C. ("BSAA"), an affiliate of BAIA, manages the Strategic Alliance Funds (the "SAF Funds") that provide seed capital to emerging alternative asset managers (the "SAF Managers") in exchange for a revenue share arrangement. Seiga Asset Management Limited, a SAF Manager, is a sub-adviser to the Fund. The revenue generated for BSAA related to the Fund's investment with a SAF Manager is rebated to the Fund. The Fund will not otherwise participate in any of the economic arrangements between the SAF Funds and any SAF Manager with which the Fund invests.*
- *Blackstone Strategic Capital Advisors L.L.C. ("BSCA"), an affiliate of BAIA, manages certain funds (the "BSCA Funds") that acquire equity interests in established alternative asset managers (the "Strategic Capital Managers"). One of the Strategic Capital Managers in which the BSCA Funds have a minority interest is Magnetar Capital Partners L.P., a control affiliate of Magnetar Asset Management LLC, a sub-adviser for the Fund. The Fund will not participate in any of the economic arrangements between the BSCA Funds and any Strategic Capital Manager with which the Fund invests.*
- *Blackstone Real Estate Special Situations Advisors L.L.C. ("BRESSA"), an affiliate of BAIA and an indirect wholly-owned subsidiary of Blackstone Inc., serves as a Sub-Advisor Sub-Adviser. BRESSA invests primarily in liquid, commercial and residential real estate-related debt instruments.*
- *Blackstone Liquid Credit Strategies LLC ("BX LCS"), an affiliate of BAIA and an indirect wholly-owned subsidiary of Blackstone Inc., serves as a Sub-Adviser. BX LCS invests primarily in below investment grade corporate credit.*
- *Blackstone utilizes technology offered by Arcesium LLC ("Arcesium") to provide certain middle- and back-office services and technology to the Fund. The parent company of a Sub-Adviser owns a controlling, majority interest in Arcesium and Blackstone Alternative Asset Management L.P. owns a non-controlling, minority interest in Arcesium.*

Other Activities of Blackstone or the Sub-Advisers. The activities in which Blackstone, the Sub-Advisers, or their affiliates are involved in on behalf of other accounts may create conflicts of interest or limit the flexibility that the Fund may otherwise have to participate in certain investments. For example, if Blackstone or a Sub-Adviser comes into possession of material non-public information with respect to a company, then Blackstone or the relevant Sub-Adviser generally will be restricted from investing in securities issued by that company. Further, Blackstone generally will be restricted from investing in portfolio companies of its affiliated private equity business.

Allocation of Investment Opportunities. Blackstone and the Sub-Advisers (or their affiliates) manage other accounts and have other clients with investment objectives and strategies that are similar to, or overlap with, the investment objective and strategy of the fund, creating potential conflicts of interest in investment and allocation decisions. These conflicts of interest are exacerbated to the extent that the other clients are proprietary or pay higher fees or performance-based fees.

Glossary of Terms: **Gross Exposure:** Reflects the aggregate of long and short investment positions in relation to the net asset value. The gross exposure is one indication of the level of leverage in a portfolio. **Net Exposure:** This is the difference between long and short investment positions in relation to the net asset value. **Long Exposure:** A long position occurs when an individual owns securities. **Short Exposure:** Short selling a security not actually owned at the time of sale. Short positions can also generate returns when the price of a security declines. **Beta:** A measure of the volatility, or systemic risk, of a security or a portfolio in comparison to the market as a whole. **Alpha:** A risk-adjusted performance measure that represents the average return on a portfolio over and above that predicted by the capital asset pricing model (CAPM), given the portfolio's beta and the average market return. More specifically, Jensen's Measure is used to calculate alpha. **Standard Deviation:** A measure of the dispersion of a set of data from its mean. The more spread apart the data, the higher the deviation. Standard deviation is calculated as the square root of variance. **Basis points (BPS):** Refers to a common unit of measure for interest rates and other percentages in finance. One basis point is equal to 1/100th of 1%, or 0.01%, or 0.0001, and is used to denote the percentage change in a financial instrument.

Glossary of Indices: Market indices obtained through Bloomberg. HFR Indices obtained through HFR Asset Management. **MSCI World Index TR:** Market capitalization weighted index designed to provide a broad measure of large and mid-cap equity performance across 23 developed markets countries. **HFRX Global Hedge Fund Index:** Designed to be representative of the overall composition of the hedge fund universe. It is comprised of all eligible hedge fund strategies falling within four principal strategies: equity hedge, event driven, macro/CTA, and relative value arbitrage. Strategies are asset weighted based on the distribution of assets in the hedge fund

industry. **Barclays Global Aggregate Bond Index TR:** Flagship measure of global investment grade debt from twenty-four local currency markets. This multi-currency benchmark includes treasury, government-related, corporate and securitized fixed-rate bonds from both developed and emerging markets issuers. **Morningstar Multistrategy Category:** Represents the average performance of mutual funds categorized as “multistrategy” funds by Morningstar, Inc.
